<b>What is the overall <u>deductible</u>?</b>	<b>\$1,550</b> /employee or <b>\$2,275</b> /employee + spouse or <b>\$2,275</b> /employee + children or <b>\$3,000</b> /employee + family. All <u>Providers</u> .	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the policy, the overall family <u>deductible</u> must be met before the <u>plan</u> begins to pay.
<b>Are there services covered before you meet your <u>deductible</u>?</b>	Yes. <u>Prescription Drugs</u> and <u>Preventive care for In-Network</u> and <u>Out-of-Network Providers</u> and telemedicine visits with Live Health Online. **Does this plan provide Minimum Essential Coverage? Yes**

Minimum Essential Coverage generally includes plans, health insurance available through the Marketplace or other individual market policies, Medicare, Medicaid, CHIP, TRICARE, and certain other coverage. If you are eligible for certain types of Minimum Essential Coverage, you may not be eligible for the plan tax credit.
